# MINUTES OF THE 39<sup>TH</sup> ANNUAL GENERAL BODY MEETING HELD ON 17/11/2019 AT OUR BUNTARA BHAVANA, BANER, PUNE - 411045.

Meeting had begun with lighting the lamp along with devotional prayer songs & subsequently offered condolences for all the family members of our community who have lost their loved ones by observing a minute's silence.

- 1. Meeting was called to order by president at 11 am sharp. Thereafter the meeting had been adjourned for an hour for want of quorum. At 12 pm, again President Santosh V Shetty had called the adjourned meeting to order and welcomed all the members for AGM 2019. The Hon. President, President, VPs, Secretary, Treasurer, Chairperson LW, Chairman of both regional committees, Chairman of YW(Total 10 persons) were at the stage. The attendance sheet of the said meeting has been annexed in Annexure-1.
- 2. Secretary Ajith Hegde read out the minutes of the last AGM held on 25th November, 2018 and the same was approved by the house unanimously.
- 3. Proposed by Mr Ganesh Punja(NZ Chm.) and seconded by Mr Ravi K Shetty(SZ Chm.)
- 4. With regard to secretarial report, Secretary Ajith Hegde said the details of activities undertaken by the main Sangha, Ladies Wing, Youth Wing, & regional committees during the year from last AGM to this AGM have been separately mentioned in the AGM report 2019. He also informed the house that these said reports will be presented in the upcoming annual get together (26/1/2020) as traditionally followed. He thanked all members for their contributions in making all these events successful during the year 2018-19.
- 5. Treasurer, Mr. Y. Chandrahas Shetty had presented for approval & adoption, the audited Balance Sheet & income & expenditure A/C 2018-19, which he said, had been already circulated with Annual Report 2018-19. He also specifically mentioned various expenditure on objectives of the trust like social, educational, medical aids given to needy members, annual picnic, annual Sports, annual get together etc and fund deposited under Kalpavruksha Yojana a/c, which is dedicated to promote social, economic, cultural, medical & educational progress & advancement of our members. He also presented in detail the total fund received for the construction of our Bhavana up to 31/10/2019, which consists of donations from our community members, sale proceeds of our plot at Katraj & office at shantikunj, sale of construction scrap etc and also details of expenditure to that date for the construction work of our Cultural Centre which includes building, furniture & fixture, interior, plant & machinery & also mentioned of inaugurations expenditure.

Mr Vikram Sadanada Shetty raised the concern of the expenditure account presented by the Treasurer in the house, not reflecting the true & correct state of affairs of the Sangha as well as on auditors remarks at schedule no: 12, point no: 11 on page no; 31 of our annual report-2018-19.He had also submitted a letter, signed by most of our ex-presidents of our sangha, mentioning the same to Bunts Sangha Pune's office at Baner on 16/11/19 at 4.35 pm. And also mentioned in the said letter recommending for an independent committee be appointed with experts in the field of chartered accountancy & engineering for verification of entire accounting of our Sangha & subsequently convene special general body for final approval of the same. The copy of the said letter has been annexed in Annexure-2.

In reply to Vikram S shetty's remark, Treasurer, Mr. Chandrahas Shetty said all books of A/Cs were open for checking & verification till 12/11/2019 at our office as per notes mentioned in Annual Report 2019 & prior notifications to this effect had been given in annual report 2018-19, website, official whatsapp groups etc but there were no queries regarding accounts or anything till that day except letter from ex-presidents received on 16/11/2019 which was received after the stipulated time.

In reply to Mr. Vikram Shetty, Mr. Santosh Shetty said that the Accounts were open all this time and it is inappropriate to raise concern so long after the completion of construction work. Although he guarantees that all have been done with honesty due diligence and true to the goal. He also said, with regard to the said letter, he subsequently met most of our ex-presidents along with office bearers & collected a consent letter signed by them, saying that Annexure-2 letter had been received under duress and pretense. The copy of the said letter has been annexed in Annexure -3

VP, Mr. Mohan Shetty endorsed Mr. Santosh Shetty's stand and at the same time he demanded the list of all our donors along with their PAN details.

Mr. Ganesh Shetty and Mr. Vishwanath Shetty both MC members, had endorsed the view expressed by president Mr. Santosh Shetty.

Thereafter majority of the members convinced about the explanations given by the treasurer as well as other MC members with regard to the final accounts of 2018-19 & passed by majority votes.

And same was Proposed by Mr Kiran Rai (Spl. Invitee for MC) and seconded by Mr Shekar C Shetty(SZ. Secretary).

Regarding the proposal of amendments in our bye laws:

a) Amendment to section 3.3, A (a) of our bye law that "The term of office of the Hon.President & Hon. General Secretary shall be for 2 years at a time and can be re-elected for maximum two more terms but not exceeding more than three terms that means total six years in continuity.They can contest for this post after the gap of one term, which means two years. After discussion & deliberation, it has been decided as follows:

"It is hereby resolved & approved that Section 3.3.A(a) that "The term of office of the Hon. President & Hon. General Secretary shall be for 2 years at a time and can be re-elected for maximum one more term provided the terms said Hon. President & Hon. General Secretary shall not be extended more than four years in continuity. They can contest for this post after the gap of one term, which means two years".

Proposed by: Suchitra S Shetty (LW Sec.), Seconded by: Saritha C Shetty (LW com.)

6. Secretary Ajith Hegde proposed the name of M/s Dayananda Shetty and Co. as auditor for year 2019-20. Also mentioned that auditors has been giving various services like account writing, TDS return, GST return, auditing of final a/cs, IT return, Charity commission compliance etc for several years to the Sangha at very nominal fee. Moreover he has been prompt & honest in all accounting matters including advising us in that respect periodically. The house felt that there is no need for changing the auditor and it was unanimously passed as follows:

"It is resolved that M/s Dayananda Shetty and Co hereby be appointed as the auditors for the year 2019-20 of Bunts Sangha Pune and the managing committee is authorized to fix the fees".

7. With permission of the Chair.

President report: Mr Santosh Shetty mentioned that few unfinished work are to be completed on priority basis,

Need to obtain Completion certificate from PMC for air conditioned banquet hall at level 1 by using additional FSI granted to our Sangha of road widening, it is already in process & assigned to architect, Mr Sathbai & Prakash Kulkarni.

Regarding the construction work of kitchen at level 0, most of the civil work has been completed; installation of the exhaust system is pending.

Mechanized parking at basement to be made functional, negotiation is on with the vender, expected to be fixed in immediately.

He extended his heartfelt gratitude to all members of the main com., LW, regional com., YW & others for their help & contribution in successful completion of all activities undertaken during this last year.

8. Since no other issues were raised in the house, the meeting was adjourned with vote of thanks by Secretary Ajith Hegde & concluded with national anthem, followed by buffet non-veg lunch.

### SCHEDULE NO.12: NOTES FORMING PART OF ACCOUNTS FOR THE YEAR ENDED 31ST MARCH, 2020.

#### I. STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

#### A. ABOUT THE TRUST

BUNTS' SANGHA, PUNE is a public charitable trust domiciled in India and incorporated under the provisions of Maharashtra Public Trust Act,1950. The trust is also registered under Section 12A of the Income Tax Act, 1961.

#### B. BASIS FOR PREPARATION OF FINANCIAL STATEMENTS

The Financial Statements are prepared under historical cost convention in accordance with generally accepted accounting principles in India. All income and expenditure having material bearing on the Financial Statements are recognized on an accrual basis except contribution payable to the Charity Commissioner which is accounted on payment basis. The preparation of Financial Statements requires the Management to make certain estimates and assumptions considered in the reported amounts of Assets and Liabilities (including Contingent liabilities) as on the date of the Financial Statements and the reported income and expenses during the reported period. The Management believes that the estimates used in preparation of the Financial Statements are prudent and reasonable. Actual results could differ from these estimates. Any changes in such estimates are recognized prospectively.

#### C. USE OF ESTIMATES

The preparation of financial statements are in conformity with the generally accepted accounting principles requires the management to make judgments, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities and the disclosure of contingent liabilities, at the end of the reporting period. Although these estimates are based on the Management's best knowledge of current events and actions, uncertainty about these assumptions and estimates could result in the outcomes requiring a material adjustment to the carrying amounts of assets and liabilities in future periods.

#### D. FIXED ASSETS & DEPRECIATION

Fixed Assets are stated at their original cost of acquisition including taxes, duties, freight and other incidental expenses relating to the acquisition and installation of the concerned assets less depreciation.

Depreciation is provided on fixed assets at rates prescribed in the Income Tax Rules on "Diminishing Balance Method".

#### E. REVENUE RECOGNITION

Revenue is recognized to the extent that it is probable that the economic benefits will flow to the trust and the revenue can be reliably measured

a. Interest income on Bank fixed deposits is recognized on a time proportion accrual basis taking into account the amount outstanding and the rate applicable.

- b. Donation income is recognized on receipt basis.
- c. All other income is recognized on an accrual basis.

#### F. EXPENSES

Expenses are accounted on accrual basis and provisions are made for all known liabilities and losses based on available information.

#### G. CONTRIBUTION TO EARMARKED FUNDS

Contribution received with a specific direction towards earmarked funds like Life Membership Fees Fund, Building Fund, Education Fund, Patrons Fund, Kalpavriksha Yojana Fund etc. is credited to the respective Fund account and treated as corpus of the trust.

#### H. INVESTMENTS

Investments are recognized at actual cost including cost incidental to acquisition, if any. Investments include long term fixed deposits with various banks. Investments include the accrued interest receivable and credited as interest income in Income and Expenditure Account.

#### I. INCOME TAX

Current Income Tax is measured at the amount expected to be paid to the tax authorities considering the exemptions available under sections 11 and 12 of the Income Tax Act . Deferred Tax Assets and Deferred tax Liabilities, if any, is not recognized in the books of accounts.

#### J. COMPARATIVES

Comparative financial reporting is presented in accordance with the 'Corresponding Figure' financial reporting framework set out in auditing and assurance standard 25 on "Comparatives'. Accordingly amount and other disclosures for the preceding year are included as an integral part of the current year financial statement, and are to be read in relation to the amounts and other disclosures relating to the current year.

- K. Contingent liabilities are not provided for in the Accounts.
- L. In the opinion of the Trustees, the current assets, loans and advances will realize a value not less than the amounts stated in the Balance Sheet, if realized in the ordinary course of operations.
- M. Previous year figures are regrouped / reclassified wherever necessary to make the figures comparable with the current year presentation.
- N. Funds Collected by the members of Ladies Wing of the Sangha after setting of the expenses incurred are credited to the "Ladies Wing Fund" account.
- O. Rules & regulations for collection and utilization of funds like Kalpavriksha Yojana, Kalpavruksha Trimasika, Education Aid, Medical Aid have not been framed by the managing committee.
- P. FDA License for preparation of food in the kitchen, Employees State Insurance Scheme Registration, Employees Professional Tax Registration, Health License from Pune Municipal Corporation for Accommodation facilities provided etc. applicable to the Sangha is not yet obtained.
- Q. No Professional Tax has been deducted from the employees salary.
- R. No Statutory compliances by various contractors like police verification proof, Employees State Insurance Scheme Contribution proof is obtained and kept on record since it is the responsibility of the principal to ensure compliances for workers working in the premises of the Sangha.
- S. Managing Committee is yet to formulate policy for investment of surplus funds lying current and savings bank accounts.
- T. During the year cost of following assets shown under Community Hall Building as on 31st March, 2019 have been capitalized separately and are treated as Machineries and Equipment for the purpose of depreciation and differential depreciation of Rs. 13,46,597/- for the year 2018-2019 have been provided in the books of accounts.
